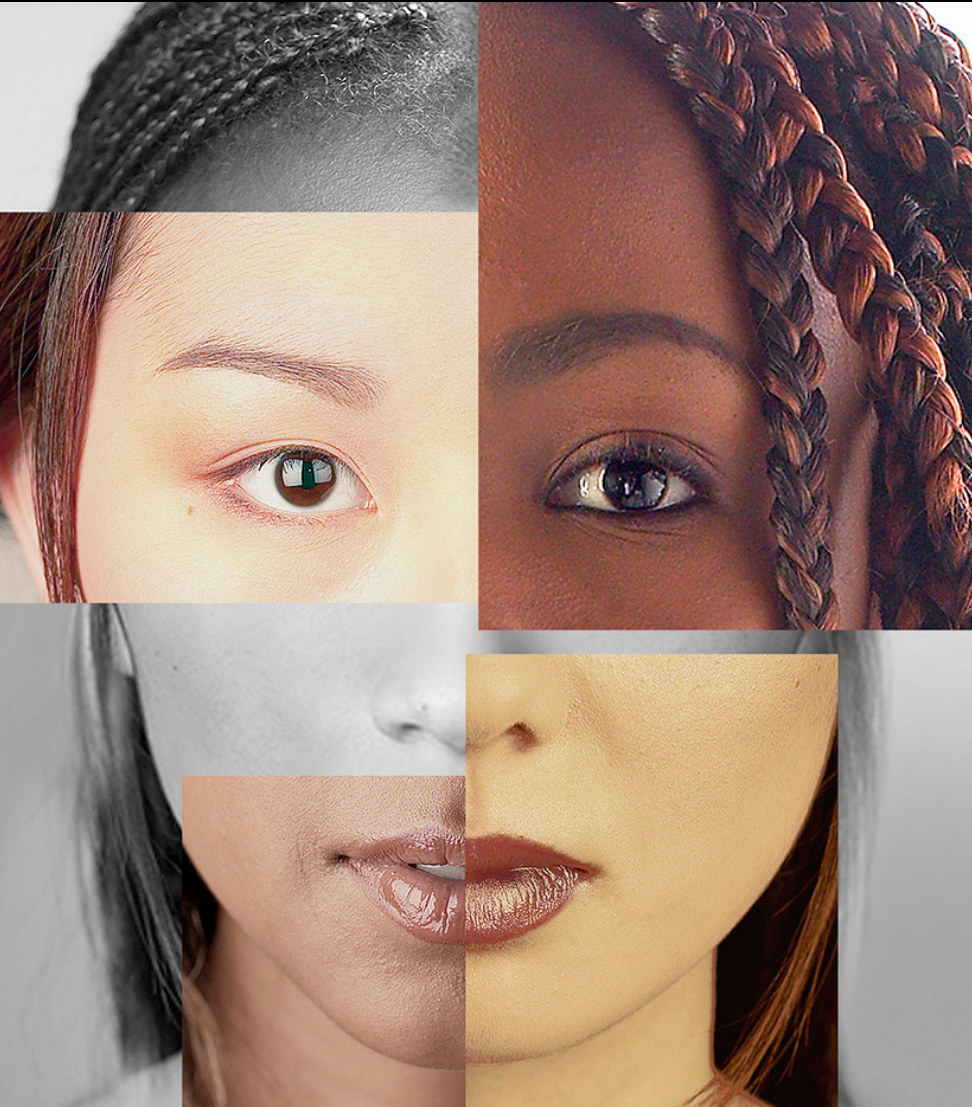

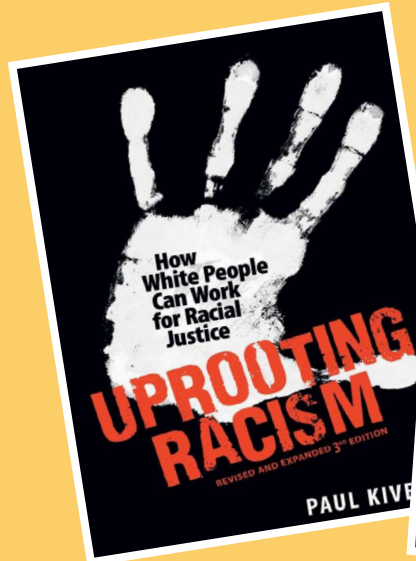

DESCRIPTION:

This event will kick-off the Race Matters Dialogue and Educational Series in the Fall by hosting a half-day workshop on race. Led and facilitated by Paul Kivel, a renowned national and international award-winning author, educator and activist on the issue of race, this workshop will provide participants with a context, analysis and framework on the various levels and forms of power; offer a safe space for participants to deeply examine the impact that racism has had in their daily lives; and to build cross-cultural alliances based on mutual understanding and respect of their differences while working towards a common purpose and goal of working towards racial justice.

While it is widely known how racism have, and continues to negatively affect people of color in all segments of our society, Race Matters will also explore ways that white people have been hurt and separated from the conversation about race in order to be full participants, allies and partners towards racial justice with people of color. Providing a shared space for understanding through dialogue and education between people of color and white people can lead to healing from the effects of racism; establish or strengthen cross-cultural alliances; and to work towards community strategies and solutions that can reduce racial disparities and inequities in Marin County's healthcare, education, criminal justice, economic and environmental housing systems.

EDUCATIONAL AND DIALOGUE PRESENTATION SERIES:

In the subsequent weeks and months after the workshop, various communities throughout Marin will host a series of conversations and educational presentations on topics such as healthcare, environmental housing, education, criminal justice and economics through the lens of race. Each conversation and educational presentation will bring a diverse panel of subject matter experts who will provide their professional and personal perspectives and insights based on current evidence-based research information and historical context. Each topic of conversation and presentation will be approximately two (2) hours in length at different locations, days and times of the week.

At the conclusion of the Race Matters Dialogue and Educational series, participants will be encouraged to participate in Marin County's 2nd Annual Equity Summit in November 2017 that is being planned by a host of community organizations throughout Marin County.
